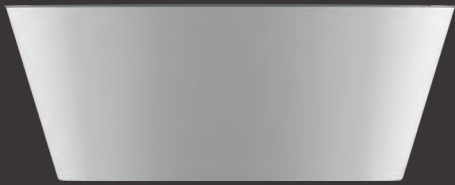

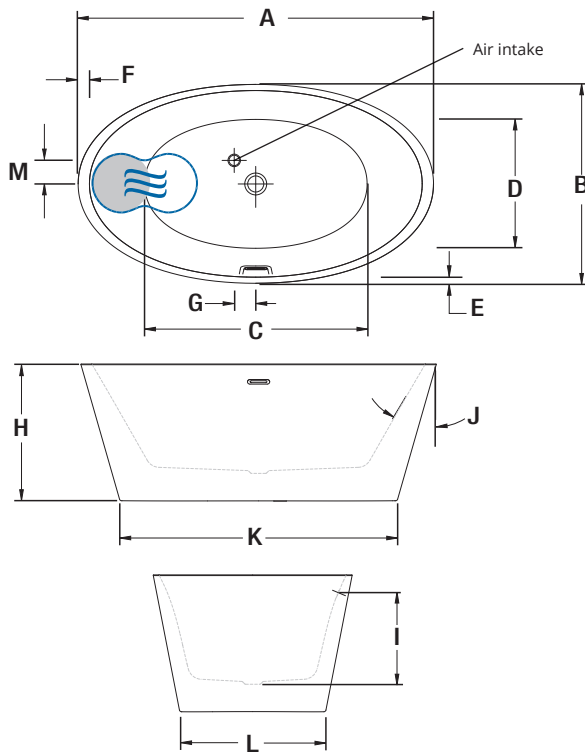

<b>Hot water supply required</b>	The hot water supply should be 70% or more of the bath's total water capacity.
<b>Turbine</b>	Access to the pump must be at least 18" x 22". <b>Standard connection is 20 A, 120 V, 60 Hz</b> , dedicated line with a Ground-Fault Circuit Interrupter (GFCI). <b>For any additional option, a second line is needed 15 A, 120 V, 60 Hz</b> , dedicated line with a GFCI. Air vent necessary: 2" x 4" minimum.
<b>Others</b>	<ul style="list-style-type: none"> <li>- The Geysair is located on the same side as the heated backrest. It must <b>NOT</b> be relocated. It must be <b>connected to the hot water supply</b> and be accessible (provide access).</li> <li>- Faucet must be freestanding or wall-mounted.</li> <li>- The turbine must be <b>remotely installed</b>.</li> <li>- Controls cannot be installed on the deck of the bath.</li> </ul>
